### Formula:

Each 100 ml contains:

Target species: Equine sports exclusively.

#### Routes of application:

Apply orally with syringe.

Insert the syringe into the bottle, invert it upside down and letting it load the syringe by pulling the plunger until you reach the desired dosage

Dosage: 4 g per 100 kg.

<u>For acute or subacute</u>: Administer every 12 hours for 10-14 days or until remission of symptoms.

<u>For chronic cases</u>: Administer every 12 hours and can extend up to 28 days treatment.

The dosage is up to the acting professional, who will assess the state of the animal in each case.

Store between 5 and 25  $^{\circ}\text{C}$  in a cool , dry place.

Avoid use in animals with liver disease and / or gastrointestinal ulcers .

Do not administer to animals with hypersensitivity to the active , horses for human consumption , pregnant mares close to delivery, lactating animals or animals with cardiac arrhythmias .

Antitussives not used simultaneously by reducing the cough reflex and accumulation of mucus, sympathomimetic amines anesthetics, cardiac glycosides, amphotericin B, ampicillin, erythromycin, tetracycline, trypsin, metal solutions containing di and / or trivalent and iodine solutions.

If infectious etiologies accompany the product with appropriate antibiotic treatment. This medication should be used by a veterinary doctor .
